

In accordance with Articles 101, 102, 103 and Article 142, Paragraph 1 of the Bankruptcy Law of the Federation of Bosnia and Herzegovina ("Official Gazette of the Federation of BiH", Nos. 29/03, 32/04, 42/06, 52/18), the Record/Decision of the Municipal Court in Sarajevo – Creditors' Assembly of Hidrogradnja d.d. Sarajevo in bankruptcy No. 65 0 St 569320 16 St dated 21 August 2025, the Decision of the Creditors' Committee of Hidrogradnja d.d. Sarajevo in bankruptcy No. 70-2/25 dated 10 December 2025, and **in accordance** with the Law on Amendments to the Law on the Interest Rate on Public Revenues ("Official Gazette of the Federation of Bosnia and Herzegovina", No. 77/25 of 8 October 2025), **the Bankruptcy Trustee of "Hidrogradnja" d.d. Sarajevo – in bankruptcy hereby announces:**

PUBLIC CALL

for the sale of the business entity Hidrogradnja d.d. Sarajevo in bankruptcy through a public oral auction

Starting price: BAM 88,067,552.50
or the equivalent amount in a foreign currency (EUR or USD) at the exchange rate of the Central Bank of Bosnia and Herzegovina on the payment date

CONDITIONS OF SALE:

1. The business entity Hidrogradnja d.d. Sarajevo in bankruptcy shall be sold in its legal and physical condition as of the date of sale, on an "as seen" basis, without the right to subsequent complaints.
2. The sale shall be conducted through a public oral auction.
3. The stated value of the business entity represents the starting price specified in the tender documentation, and the business entity may not be sold below this price.
4. The public oral auction for the sale of the business entity shall be held on 31 March 2026 at 12:00 noon at the seller's registered office, Izeta Čomare bb, Ilidža – Sarajevo.
5. Continuation of operations – the core business activities of Hidrogradnja d.d. Sarajevo, with the retention of the existing number of employees.
6. All fees and taxes related to the transfer of ownership of the business entity, as well as the preparation of documentation and legal actions required for the transfer of ownership, shall be borne by the buyer.

RIGHT TO PARTICIPATE:

1. The right to participate in the public oral auction shall be granted to all legal and natural persons who pay a deposit in the amount of 0.25% of the starting price, i.e. BAM 220,168.88, or the equivalent amount in a foreign currency (EUR or USD) at the exchange rate of the Central Bank of Bosnia and Herzegovina on the payment date.
2. The deposit must be paid into the transaction account (BAM) of "Hidrogradnja" d.d. Sarajevo – in bankruptcy No. 102 708 00000 19166 with Union Bank Sarajevo, or account No. 186 101 031 030 4671 with Turkish Ziraat Bank, or the foreign currency account No. 1861011200180440 with Turkish Ziraat Bank, so that the deposited amount is credited to the specified account no later than 31 March 2026 by 10:00 a.m.
3. **The deposit in the amount of 0.25% of the starting price, i.e. BAM 220,168.88, or the equivalent amount in a foreign currency (EUR or USD) at the exchange rate of the Central Bank of Bosnia and Herzegovina on the payment date, may also be paid by another legal or natural person on behalf of and for the account of the interested legal or natural person wishing to participate in the auction, with a clear indication in the payment reference of**

the person for whom the deposit is being paid. In such a case, the legal or natural person making the payment on behalf of and for the account of the interested bidder must possess a valid legal document (a contract or a notarized power of attorney) authorizing them to make the deposit payment and to pay for the tender documentation.

4. The Commission shall verify whether the deposit has been credited to the account of "Hidrogradnja" d.d. Sarajevo – in bankruptcy within the specified deadline. If the deposit has not been paid within the prescribed time, the candidate shall not be allowed to participate in the public auction.
5. All legal and natural persons are required to purchase the tender documentation, which contains all relevant information on the business entity being sold. The tender documentation may be purchased at the seller's registered office at Izeta Čomare bb, Ilidža, Sarajevo, at a price of BAM 1,000.00.
6. Payment may be made at the seller's cashier's office or into one of the aforementioned bank accounts.
7. After purchasing the tender documentation, interested bidders may, with prior written notice (two days in advance), inspect the actual condition of the business entity and request additional clarifications, with a record of the meeting and information obtained to be drawn up.
8. All additional information regarding the auction may be obtained on working days between 12:00 and 15:00 hours at telephone number: +387 61 338 937.
9. Applications for participation in the public auction, together with proof of payment of the deposit and proof of purchase of the tender documentation, must be submitted no later than one hour prior to the commencement of the auction.
10. Registration for the public oral auction and participation in the auction may be carried out exclusively by the potential final buyer, upon submission of **proof of payment of the deposit and proof of purchase of the tender documentation, which must be submitted to the Public Auction Commission no later than one hour prior to the commencement of the auction.** The auction forms (Forms No. 1, No. 2, No. 3 and No. 4) shall be obtained at the seller's registered office at Izeta Čomare bb on the day of the public oral auction.
11. The public auction shall be conducted and concluded in accordance with the provisions of the Enforcement Procedure Law, as well as in accordance with the Additional Rules for Public Auction adopted by the Bankruptcy Trustee.
12. The Additional Rules contain the course of the public auction, as well as all other information relating to the public auction, and they form an integral part of the tender documentation.

The Bankruptcy Trustee reserves the right to amend, extend or cancel this Public Call due to unforeseen circumstances.

In accordance with any amendments to this Public Call, the Additional Rules shall also be amended accordingly.
